2020 SCHOOL FEES

At the Budget & AGM meeting held on 22 October 2019, the school fees for 2020 were ratified at R35 200.00 per learner per annum.

The payment of school fees is compulsory in terms of the South African Schools Act. School fees are also payable in advance and fall outside the National Credit Act. This means that your obligation to school fees comes before any credit payment e.g. repayment of hire purchases. Payment of school fees is the responsibility of both parents, even in the case of a divorce.

We urge all parents who may be in genuine need of financial assistance in terms of the subsidy system or who may have specific financial difficulties, to make an appointment early with the school bursar, Mrs Gillian Scott, to discuss and decide how best to pay their school fee obligation.

It is the school's last resort to hand over parents to debt collectors but unfortunately this will be done and the attachment of your assets by the sheriff of the court is not a pleasant experience.

The following options are available when deciding how you would like to pay your 2020 school fees. Please note that in order for the discounts to be applicable, we will adhere **strictly** to the cut-off dates.

1. Upfront settlement by 31 January 2020.

All payments made in full, strictly on or before 31 January 2020, will qualify for a 10% discount, reducing the annual fees to R31 680.00. **Credit card payments will not qualify for the discount.**

2. Upfront settlement by 28 February 2020

All payments made in full, strictly on or before 28 February 2020, will qualify for a 7% discount, reducing the annual fees to R32 736.00. **Credit card payments will not qualify for the discount.**

3. Monthly debit order - Signed forms to be returned by Wednesday 20 November 2019.

Monthly payments made by debit order over 10 months with the school without default will qualify for a 5% discount in the last month, reducing the annual fees to R33 440.00.

Debit orders will run from February to November 2020 inclusive, for an amount of R3 520.00 per learner, dated for either 1st or 15th of the month, with the discount of R1 760.00 per learner given on the final instalment.

4. Monthly payments – on or before the 1st of each month

Parents not wishing to take up options 1, 2 or 3 above will be required to pay an amount of R3 520.00 monthly per learner for the months of February to November 2020.

NOTE : Only options 1 – 3 will qualify for discounts as outlined. Any other form of payment will NOT qualify for a discount and the full fees will be applicable per child enrolled.

No sibling discounts offered.

A term's notice is required in the event of your child leaving the school; and payment of school fees for that term remains payable in full.

5. Subsidy payments

Subsidy application forms are available from the finance office and will be assessed in accordance with the criteria stipulated by the Department of Education.

All those who have received previous assistance and still require assistance MUST re-apply each year. Subsidies expire each year and are not carried forward.

It is imperative that all subsidy applications be collected before Friday 24 January 2020 and returned to the finance office before 28 February 2020. In accordance with the resolution passed at the AGM /Budget meeting no application will be accepted after this date.

Applications must be accompanied by ALL the required documentation and signed by a Commission of Oaths.

Should payment not be paid according to the above options, the account will be deemed to be in arrears, and the School will then proceed with legal action.
